An Assembly of Principals and Electors of the Parish of St. Peter will be held in the Parish Hall on Tuesday 05 November 2019, at 7.00pm to:-

- 1. Receive, and if deemed advisable, approve the Act of the Parish Assembly held on Tuesday 13 August 2019 as unfortunately not yet approved.
- 2. Receive, and if deemed advisable, approve the Act of the Parish Assembly held on Tuesday 03 September 2019
- 3. In accordance with Article 32 of the Parish Rate (Jersey) Law 2005, to elect two members of the Assessment Committee, for a period of three years as the term of office of two officers are due to expire in November 2019.
- 4. Elect three Principals resident in the Parish to serve as members of the Comité des Chemins for a period of three years, the term of office of the present holders, due to expire in November 2019.
- 5. Elect two Inspecteurs des Chemins for each Vingtaine for a period of three years, the term of office of the present holders, due to expire in November 2019.
- 6. Elect four Principals to serve as members of the Cimetiere a L'usage de tous les Cultes for a period of three years, the term of office of the present holders, due to expire in November 2019.
- 7. Elect Officers du Connetable for various Vingtaines within the Parish, for a period of three years.

1 The minutes of the previous assembly held on Tuesday 13 August which had been unapproved at the last assembly, were approved and proposed by **Sally Camara**, seconded by **David Robinson.**

2 On the proposition of **Joao Camara**, seconded by **Julia Quenault**, the minutes of the previous assembly held on Tuesday 03 September 2019, which had been previously handed out, were approved.

3 Rates Assessors

Roger Noel proposed **Jean Shales** for her third term of office and thanked her for all her hard work over the years, he also proposed **Zoe Rive** who is also continuing. Zoe took over the term of office of the late Terry Avery as a rates assessor and is willing to continue for a new three year term.
