An Assembly of Principals and Electors of the Parish of St. Peter will be held in the Parish Hall on Tuesday 03 September 2019 at 7.00 p.m. to :-

- 1. Receive, and if deemed advisable, approve the Act of the Parish Assembly held on Tuesday 13 August 2019.
- 2. To take into consideration the following recommendations to the Assembly of Governor, Bailiff and Jurats for licences for the year 2019.
- Company: Dunells Premier Wines Beaumont La Route de la Haule St Peter JE3 7YD
- **Reason:** First Category Licence: Purpose to the sale of alcohol to corporate events and use of a mobile wine bar.
- Business: Dunells Limited Beaumont La Route de La Haule St Peter JE3 7YD

Unfortunately the Constable was unable to attend this assembly due to ill health, Therefore apologises were given by the Senior Procureur, Julia Quenault who chaired the meeting on his behalf.

1 The minutes of the previous assembly held on Tuesday 13 August were not approved as no Proposer or Seconder was available from this meeting therefore they are to be carried forward to be approved at the next assembly. 2 **Marcus Pallot** from Carey Olsen addressed the assembly to advise what this application is regarding: He has known Neil and Jane Pinel for several years and was approached by them to assist with this application. The record of Dunell's goes back to 1969, known for the selling of alcohol and prior to this grocery too. There have never been any issues and have always complied with the law.

Their plan is to sell wine for consumption on the premises. Neil Pinel is keen to move the business forward. The current licensing law (1974) was designed for social environments, which is different to today. A First category licence i.e. running a pub, which is not what they want to do is the most suitable as no other categories apply.

Their current Sixth category licence (Off licence) means that all alcohol purchased must leave the premises unopened, therefore to assist them with their corporate evenings they have been using someone else's licence and obtaining the relevant extensions to hold the events, this is time consuming, difficult and also administratively burdensome.

They have recently re-furbished the building at Beaumont and hope to hold more events and to be able to sell a bottle or glass on these nights.

A secondary purpose is to have the use of their mobile van at other events, they would ensure all relevant permissions / permits are in place.

In summary, these are the requirements for their 1st category licence application. No further comments made.

The Procureur asked for any comments from the Chef de Police, Joao Camara stated that there have never been any issues or call outs to Dunell's and is always run in accordance with the law and therefore has no objections on behalf of St Peters Honorary Police.

William Dolan proposed the application and was seconded by **Andrew Shrimpton**. There were 23 people attending the assembly, all For the application, none against and no abstentions.

As there were no further business the Senior Procureur thanked everyone for attending.

This concluded the business of the Assembly.
