

PAROISSE DE ST. PIERRE

The Fifteenth day of December Two Thousand and Twenty-Two

An Assembly of Principals and Electors of the Parish of St. Peter will be held in the Parish Hall on Thursday 15 December 2022, at 7.00pm to: -

1. Receive, and if deemed advisable, approve the Act of the Parish Assembly held on Thursday 18 August 2022.
2. In accordance with Article 32 of the Parish Rate (Jersey) Law 2005, to elect two members of the Assessment Committee, for a period of three years as the term of office of two officers are due to expire in November 2022.
3. Elect three Principals resident in the Parish to serve as members of the Comité des Chemins for a period of three years, the term of office of the present holders, due to expire in November 2022.
4. Elect two Inspecteurs des Chemins for each Vingtaine for a period of three years, the term of office of the present holders, due to expire in November 2022.
5. Elect four Principals to serve as members of the Cimetiere a L'usage de tous les Cultes for a period of three years, the term of office of the present holders, due to expire in November 2022.

A minute silence was taken to recognise those who had lost their lives in the recent fishing and Haut du Mont incidents in the Island.

Procureur Robert Surcouf addressed the assembly and apologised for the absence of the Connetable, Richard Vibert, who had been kept in the States Assembly and Council of Minister meetings. Apologies also received from Procureur Chirs Benest.

1 On the proposition of **David Robinson**, seconded by **Marion Romeril**, the minutes of the assembly held on Thursday 18 August, which had been previously handed out, were approved.
