- 1 On the Proposition of **Joao Camara**, seconded by **Christine Coen**, the minutes of the assembly held on 25 April 2023, which were previously handed out, were approved.
- 2 Mark Capern proposed Helen Mary Elizabeth Evans for the role of Committee member for St Peters Youth & Community Centre. Helen was born in Jersey, lives in St Peter and attended Beaulieu Convent school. Helen used to be in Finance working for Ports of Jersey but now is teaching Maths & Statistics. This proposal was second by Sally Johnson. As there were no further nominations, the Constable congratulated Helen and advised no swearing in is required.

**3 Ian Osborne**, Head of Retail at Durrell addressed the assembly. He advised that as part of the latest Durrell Initiative, The Tortoise Trail, which begins on 01 July 2023, they have got together with La Mare Vineyards to create a merchandise pack which consists of a boxed fudge and a Limited-edition Gin. This will be sold in their shop in town and then at the Airport concession.

Beyond the trail date, they are hoping to create a Jersey Zoo Durrell label for the gin they are also in talks with the breweries to create a Gerald Durrell bottled beer. These are all limited products but a good addition to the goods already sold.

This will fund the new tropical house at the zoo.

The Constable asked the Chef de Police, Joao Camara for comments, Joao confirmed that he never has any licensing issues at the Airport, therefore wishes them all success. This application was proposed by **Yolande Logan** and seconded by **Katherine Evans**. The Constable asked for a show of hands, unanimously in favour. No abstentions.
