- 1. On the proposition of **David Robinson**, seconded by **Louise Robinson**, the minutes of the previous Assembly held on Thursday 25 April 2024, which had been previously handed out, were approved.
- 2 The Constable advised the assembly that the licence will be subject to a condition that the licence shall not take effect until Food Retail Limited provides evidence to the Judicial Greffier that the transaction has been completed.

Advocate Kate Westwater from Appleby stood to address the assembly and advised that this application was in fact not a change in name but a new legal company. There is a corporate restructuring of the Sandpiper group and mentioned that we had probably heard in the media of them selling to Morrisons. Appleby are assisting Sandpiper through this transition for all their properties in various parishes. 'Iceland' has had a Sixth category licence previously and they plan things to be 'Business as Usual', there will be no operational changes to the hours of the shop and also hoping to re-register the current Registered manager . Morrisons have significant experience too so there should be no issues.

There were no questions from the floor, the Constable asked a member of the Honorary team and **Vingtenier D Robinson** advised he completes the Licensing checks in the Parish and has never experienced any problems with Iceland.

As there were no objections, this application was proposed by **Duarte De Freitas**, seconded by **Tanya Channing**.

Appleby will be representing all the shops at the Licensing Assembly on 20 June 2024.

Antony Bray from St Peters Garden Centre addressed the assembly, he advised he is the new operations manager for the centre, they are applying for the Third category Restaurant licence for the Baytree restaurant again. Unfortunately due to personnel issues in the past and residency issues they have struggled to get a registered manager however they are now in a position where they wish to bring back the sale of alcohol and offer an ultimate dining experience to their customers. Their proposed registered manager has previous experience in holding a liquor licence. As there were no questions from the floor or any objections, the application was proposed by **Daniel Le Mottee** and seconded by **Joyce Le Moine**. The Constable reminded them of the licensing assembly on 20 June 2024.

As there were no further business the Constable thanked everyone for attending.
