- 5 The Constable began by stating that the assembly may only be supportive of this application if all the requests made by the Fire Department in their report had been adhered to, from this he asked who was presenting this application to the assembly :

Mr William Dempsey stood and addressed the assembly, he gave a short background in that 14 months ago the Jersey Reds disappeared and the Jersey Rugby Football club took on the license and the trading of the club. They currently have 2 full time members of staff. Over this period they had a situation ,as an example, of a request from a club member to hold a wake at the club but due to their current licences they were unable to accommodate the request.

In order for the club to survive and make use of the facility , they request a 1<sup>st</sup> category licence They are planning to have a lift fitted into the club to help them make more use of the club .

The Constable asked if there was any objections to the application from a Police point of view, Joao Camara, Chef de Police stated they had none.

The Constable did ask that in their application they state to be open for private functions for 150/180 people, where are these people going to park, what is the parking facility available. As no answer he suggested that they needed to consider this in their application.

Mr William Dempsey proposed the application and this was seconded by Cliff Chipperfield. The Constable asked for a show of hands in favour of the application , this was the majority of the assembly 14 For, 0 Against and No abstentions.

The Constable wished them well and understood why they wanted to use the premises this way.

As there were no further business the Constable thanked everyone for attending.
