Meeting 261

Minutes for the Roads Committee Meeting held on Wednesday 05 November at 5.30pm.

Attended by Richard Vibert (Constable),Keith Capern, Rev Robert Harris, Martin Zimmer and Liz Cheetham , Parish Executive Officer.

Apologies from Paul Townsend.

1. **Approve and sign minutes for meeting 260** . These were approved and proposed by Keith Capern, seconded by Martin Zimmer.
2. **Budget** : Current balance of £54,350. Recently spent on various potholes £2,200, tyres for the truck and step ladder £400 and assistance with the Branchage at £720. Not a lot to do on the roads currently due to the diversions on the roads
3. **Road works** : Fillet in Le Mont Fondon. Agreed to go ahead now road has been swept. Get the contractor to look at doing these works.
 - Wall affecting road on Rue Panigot. Advised structural engineers had looked at this many years ago. We need to write to the owner to advise we believe that the wall is failing to support the road and the wall is subsiding and causing cracks in the road. The road must be supported to allow any traffic to use it.
 - Les Monts track . Agreed for a further section of track to be done. JEC have written advising they need to place an electric line in and across a property there, we agree but they must reinstate the tarmac.
 - Gully in Rue Caroline-drainage, agreed to have a look at this.
 - Rue des Fontaines weeds-feedback from J Water stating it has been 3 years so no guarantee of works. RV asked for LC to have this checked with S De Gruchy.
4. **Re-mark the crossing at Les Mielles Golf course**. Agreed for this to be done.
5. **Road signs**- Speak to Paulo to obtain list of signs that need to be ordered.
6. **Tributary channel**-Ruelle es Ruaux. I&E feel the parish should be responsible for these works. Committee agreed that not on our land so we are not responsible.
7. **Trees**- Some need replacing in Ville du Bocage, RV does not wish to plant trees of height therefore has requested that we look at shrubs. MZ advised against this however agreed to look at alternatives as RV conscious of future plans so must consider heights of future planting.
8. **Parish Assembly 09-12-25**- Nomination for all ROADS COMMITTEE & INSPECTORS. Discussed current members wishing to retake and advertisement has been placed by LC to look for new members. RV wishes to speak to current members to ensure they are aware of duties involved.
9. **Roadworks Safety course**-. As we use contractors to do major works, no further training is required at this time.

MZ reported not happy with a section of the last road sweep for La Rue du Saut Falluet. LC will report this back to the contractor.

Minutes 261 continued :

LC will speak to the outside maintenance team regarding the cutting back of banks in the parish in order for the full road width to be used and roads swept.

RV was happy with the temporary chicanes on La Rue de St Clement due to recent roadworks and would like us to look into having this on a permanent basis so to obtain some quotes for the next financial year. This will help with the speed issues.

Tom Le Gallais of I&E had notified the office of some harries fencing being placed behind the Parish pump on Rue St Clement to prevent members of the public walking up near the area of the construction of the Sewage tank for the safety as close to a drop in the bank.

Paul Townsend who is not re-standing for a role on the Committee conveyed his thanks to Richard and the other members of the committee via email.
